RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ACCEPTING AND APPROPRIATING TRANSPORTATION DEVELOPMENT ACT (TDA) ARTICLE 3 GRANT FUNDS FROM THE METROPOLITAN TRANSPORTATION COMMISSION (MTC) IN THE AMOUNT OF \$90,000 FOR THE SAFE ROUTES TO SCHOOL IMPROVEMENT FOR E.M. DOWNER ELEMENTARY SCHOOL PROJECT (CIP 0705)

WHEREAS, the Metropolitan Transportation Commission (MTC) administers Transportation Development Act (TDA) Article 3 funds for pedestrian and bicycle projects;

WHEREAS, the City of San Pablo submitted an application on January 23, 2023, requesting TDA Article 3 funding for the Safe Routes to School (SR2S) Improvement for E.M. Downer Elementary School Project, including ADA ramp upgrades, sidewalk repairs, and evaluation of a one-way street conversion to improve traffic circulation;

WHEREAS, the project was determined to be categorically exempt from environmental review under the California Environmental Quality Act (CEQA), and a Notice of Exemption was filed on January 4, 2023;

WHEREAS, on July 26, 2023, the City received an allocation letter from MTC awarding \$90,000 in TDA Article 3 funds for the project;

WHEREAS, all reimbursement requests must be submitted to MTC by August 31, 2026, for funds to be drawn by September 30, 2026.

NOW, THEREFORE, BE IT FURTHER RESOLVED that that the City Council of the City of San Pablo hereby accepts and appropriates Transportation Development Act Article 3 grant funds from the Metropolitan Transportation Commission in the amount of \$90,000 for the Safe Routes to School Improvement for E.M. Downer Elementary School Project; and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
