# GFDR: FY 2024-25 Amendment No. 3

**ADMINISTRATIVE SERVICES - FINANCE**

# History:

- ▶ General Fund Designated Revenue (GFDR) established in October 21, 2013 through the Fiscal Resiliency Reserve Policy via Resolution 2013-159.
  - ▶ *GFDR was historically utilized to prefund large expenditures including but not limited to replacement of large capital equipment information technology systems facilities and infrastructure maintenance and replacement accrued employee leave costs PERS rate increases workers compensation costs general liability costs etc. and when such costs can be anticipated it makes prudent fiscal sense to identify a funding source and set aside funds.*

# FY 2024-25 Amendment No. 1:

- Per FY 2024/25 Amendment No. 1, approved September 3, 2024, the following amounts totaling \$2,430,319 were appropriated and expensed via City Council action (via adopted resolutions) during the FY 2023-24 period through June 30, 2024, resulting in a remaining unappropriated GFDR balance of \$5,171,279 from the previously allocated expense items, as follows
