RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE COOPERATIVE AGREEMENT NO. 651 WITH THE CONTRA COSTA TRANSPORTATION AUTHORITY TO PROVIDE A CITY OF SAN PABLO LOCAL FUNDING CONTRIBUTION OF \$217,877 FOR THE COUNTYWIDE SMART SIGNALS PROJECT

WHEREAS, the Contra Costa Transportation Authority (CCTA) is leading the Countywide Smart Signals Project to modernize traffic signal infrastructure at more than 300 intersections throughout Contra Costa County;

WHEREAS, the Project will upgrade traffic signal systems along major arterial roadways to improve traffic flow, safety, and operational efficiency through advanced signal control, detection, and real-time optimization technologies;

WHEREAS, within the City of San Pablo, the Project includes upgrades at eighteen (18) signalized intersections, including eleven (11) along San Pablo Avenue, five (5) along San Pablo Dam Road, and two (2) along 23rd Street;

WHEREAS, the Project will provide system enhancements including, but not limited to, advanced traffic management systems, traffic signal synchronization, emergency vehicle preemption, transit signal priority, and remote monitoring capabilities;

WHEREAS, CCTA has secured approximately \$30.8 million in regional, state, and local funding for the Project through Measure J, Local Partnership Program Formulaic funds, and One Bay Area Grant 3 (OBAG 3) funds, which require a local funding contribution from participating jurisdictions;

WHEREAS, as the Project advances toward construction, CCTA has prepared Cooperative Agreement No. 651 to define agency roles and responsibilities and to formalize the City of San Pablo's continued participation in the Project;

WHEREAS, the City's \$217,877 contribution will be funded using Measure J Local Street Maintenance (LSM) funds that were previously appropriated as part of the FY 2025/26 Capital Improvement Program adopted by the City Council on October 6, 2025, pursuant to Resolution No. 2025-119; and

WHEREAS, approval of Cooperative Agreement No. 651 will not require additional budget authorization and will ensure the City of San Pablo remains an active partner in the Countywide Smart Signals Project.

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby:

- (1) Approves Cooperative Agreement No. 651 with the Contra Costa

Transportation Authority, in substantially the form attached to the staff report accompanying this Resolution;

- (2) Authorizes the City Manager to execute Cooperative Agreement No. 651, in a form to be approved by the City Attorney that does not substantially alter the City's rights or responsibilities from those set forth in the attached draft agreement, to establish the City of San Pablo's funding contribution in the amount of \$217,877;
- (3) Authorizes the City's local funding contribution in the amount of \$217,877 to be funded with Measure J Local Street Maintenance (LSM) Fund 230, as previously appropriated in the FY 2025-26 Capital Improvement Program; and
- (4) Authorizes the City Manager to execute any additional documents and take other actions reasonably necessary to carry out and implement the City's obligations under Cooperative Agreement No. 651.

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
