RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO PURCHASE THE FOLLOWING USING RESERVE FUND 140: FIVE (5) 2025 DODGE DURANGO POLICE INTERCEPTOR VEHICLES WITH EMERGENCY EQUIPMENT, ONE (1) MADVAC LS125 ELECTRIC LITTER VACUUM SWEEPER, ONE (1) BANDIT 200UC HAND-FED WOOD CHIPPER, ONE (1) 2025 FORD F-150 LIGHTNING ELECTRIC PICKUP TRUCK, AND ONE (1) 2023 FORD F-250 PICKUP TRUCK USING COMPETITIVELY BID COOPERATIVE PURCHASING AGREEMENTS PURSUANT TO SAN PABLO MUNICIPAL CODE SECTION 3.16.110 (E); AND SELL POLICE DEPARTMENT AND PUBLIC WORKS DEPARTMENT VEHICLES AS SUPLUS PROPERTY THROUGH PUBLIC AUCTION PURSUANT TO SAN PABLO MUNICIPAL CODE SECTION 3.16.120

WHEREAS, the Police Department (PD) operates a fleet of emergency vehicles, which are essential for its 24/7 operation, and requires replacement of vehicles that are either beyond their useful life or have been deemed a catastrophic loss;

WHEREAS, the Public Works Department (PW) is responsible for the daily maintenance and upkeep of City properties and infrastructure including security, repairs, and major maintenance of City-owned assets such as building, landscaping, roadways, and vehicles;

WHEREAS, PD and PW have identified the need to purchase five (5) 2025 Dodge Durango Police Interceptor vehicles, one (1) Madvac LS125 Electric Litter Vacuum Sweeper, one (1) Bandit 200UC Hand-Fed Wood Chipper, one (1) 2025 Ford F-150 Lightning Electric Pickup Truck, and one (1) 2023 Ford F-250 Pickup Truck;

WHEREAS, these vehicle and equipment purchases will be made through competitive, cooperative purchasing agreements pursuant to San Pablo Municipal Code Section 3.16.110 (E), which allows for cooperative procurement with authorized suppliers under existing contracts; and

WHEREAS, it is also recommended that surplus vehicles and equipment be sold through public auction in accordance with San Pablo Municipal Code Section 3.16.120 due to increased repair and maintenance costs and safety, including the following items:

- 2018 Ford Explorer (Vehicle #1807)
- 2003 Ford Expedition (Vehicle #831)
- 2014 Ford Taurus (Vehicle #865)
- 2008 Ford F-250 (Vehicle #635)
- 2010 Bandit F150 Wood Chipper (Vehicle #680)
- 2016 Ditch Witch Vacuum Trailer (Vehicle #696)

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo herby authorizes the following:

- 1. Authorization to Purchase: The City Council hereby authorizes the City Manager to purchase the following vehicles and equipment from cooperative purchasing agreements:
 - Five (5) 2025 Dodge Durango Police Interceptor vehicles for the Police Department, at a total cost not to exceed \$296,708.
 - Emergency vehicle outfitting for the Police Department from Priority 1 Public Safety, Inc., in an amount not to exceed \$108,245.
 - One (1) Madvac LS125 Electric Litter Vacuum Sweeper for the Public Works Department, at a cost not to exceed \$276,704.
 - One (1) Bandit 200UC Hand-Fed Wood Chipper for the Public Works Department, at a cost not to exceed \$52,810.
 - One (1) 2025 Ford F-150 Lightning Electric Pickup Truck for the Public Works Department, at a cost not to exceed \$56,282.
 - One (1) 2023 Ford F-250 Pickup Truck for the Public Works Department, at a cost not to exceed \$49,320.
 - Outfitting for the Ford F-150 and F-250 trucks for the Public Works Department, including lumber racks, tool boxes, and lightbars, in an amount not to exceed \$7,900.
- 2. **Total Purchase Authorization**: The total amount authorized for the purchase of the vehicles and equipment, including outfitting, is \$852,089, with a 10% contingency of \$85,209, for a total authorization not to exceed \$937,298.
- 3. **Surplus Vehicle and Equipment Sale**: The City Council authorizes the sale of the following surplus vehicles and equipment through public auction pursuant to San Pablo Municipal Code Section 3.16.120:
 - 2018 Ford Explorer (Vehicle #1807)
 - 2003 Ford Expedition (Vehicle #831)
 - 2014 Ford Taurus (Vehicle #865)
 - o 2008 Ford F-250 (Vehicle #635)
 - 2010 Bandit F150 Wood Chipper (Vehicle #680)
 - 2016 Ditch Witch Vacuum Trailer (Vehicle #696)
- 4. Fiscal Impact: The total expenditure for the purchase of vehicles and equipment will be made from the FY2024-25 Asset and Vehicle Replacement Budget (Fund 140). Any revenue funds received from the sale of surplus vehicles for the Police Department will be credited to the FY2024-25 Vehicle Replacement Account Code (102-2110-46300), and revenue funds from the sale of surplus vehicles for the Public Works Department will be credited to the FY2024-25 SLLD Program Costs and Supplies Account Code (237-3610-43500).

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
