RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING CITY MANAGER TO (1) SUBMIT APPLICATIONS ANNUALLY FOR CALRECYCLE'S PAYMENT PROGRAMS; (2) ACCEPT GRANT FUNDING, IF AWARDED, TO THE ENVIRONMENTAL SOLID WASTE STATE GRANT REVENUES ACCOUNT AND TO APPROPRIATE SAID FUNDING TO FUND STAFF TIME SPENT ON ENGAGEMENT IN RECYCLING AND LITTER CLEANUP ACTIVITIES RELATED TO THE GRANT FUNDING; AND (3) EXECUTE ALL DOCUMENTS WITH CALRECYCLE NECESSARY FOR AWARD OF THESE PAYMENT PROGRAMS

WHEREAS, pursuant to Public Resources Code Sections 48000 et seq., 14581, and 42023.1(g), the Department of Resources Recycling and Recovery (CalRecycle) has established various payment programs to make payments to qualifying jurisdictions;

WHEREAS, in furtherance of this authority CalRecycle is required to establish procedures governing the administration of the payment programs;

WHEREAS, CalRecycle grant application procedures require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle Grants;

WHEREAS, the City of San Pablo has requested and received funding in previous years from CalRecycle's Beverage Container Recycling City/County Payment Program;

WHEREAS, the goal of this CalRecycle program is to reach and maintain an 80 percent recycling rate for all California Refund Value beverage containers; and

WHEREAS, the City of San Pablo has used these funds for beverage container recycling and litter cleanup activities.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to submit an application to CalRecycle for all grant programs offered;

BE IT FUTHER RESOLVED that the City Manager is authorized to accept grant funds, if awarded, to the Environmental Solid Waste State Grant Revenues Account (256-3510-33404), and appropriate said funding to cover staff time spent on engagement in recycling and litter cleanup activities related to the grant; and

BE IT FURTHER RESOLVED that the City Manager, or his designee, is hereby authorized as Signature Authority to execute in the name of the City of San Pablo all grant documents, including but not limited to, applications, agreements, amendments, and requests for payment, reasonably necessary to secure grant funds and implement the approved grant project, the form of which shall be approved by the City Attorney;

BE IT FURTHER RESOLVED that the authorizations set forth in this resolution shall be effective for five (5) years from the date of adoption; and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
