CEQA: The Sutter Green Project is exempt from environmental review under the California Environmental Quality Act (CEQA) as a funding action, as it is not a project under CEQA nor an activity that may cause a direct or reasonably foreseeable indirect physical environment change pursuant to Public Resources Code Section 21080(a) and 14 California Code of Regulations Section 15002(d). Further, to the extent that funds are eventually used for a capital project, this project was assessed and determined to be under Section 15304(b)&(f), Categorically Exempt 15301(b)&(c). 15302(c) of the CEQA Regulations. The CEQA Notice of Exemption (NOE) was originally filed with the Contra Costa County Clerk's Office on January 31, 2022 and a revised NOE was filed on March 13, 2024.
