RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO APPROVING AMENDMENT #5 TO THE GENERAL FUND DESIGNATED RESERVES (GFDR) FOR FISCAL YEAR 2023-24, EFFECTIVE JANUARY 16, 2024.

WHEREAS, "Continue Fiscal Resilience, Fiscal Excellence and Fiscal Transparency" is an adopted City Council Priority contained in the adopted Fiscal Year 2023-2025 City Council Priority Workplan, effective May 1, 2023;

WHEREAS, the City Council formally adopted Resolution No. 2023-165 approving the General Fund Designated Reserves (GFDR) total fund balance of \$7,606,461 for Fiscal Year (FY) 2023-24;

WHEREAS, of the total \$7,606,461 FY 23-24 GFDR, \$2,207,675 had been appropriated and expensed resulting in a remaining GFDR balance of \$5,398,786;

WHEREAS, the adopted FY 2023-24 GFDR allocation of \$7,606,461 via Resolution No. 2023-165 included projected proceeds from the sale of land located on Vale Road to the Lytton Rancheria of California in the amount of \$3,050,000;

WHEREAS, the actual sale proceeds received on December 28, 2023, was \$3,045,137 resulting to a difference of \$4,863 and an adjusted remaining GFDR balance of \$5,393,923 (\$5,398,786 less \$4,863);

WHEREAS, the proposed said Resolution approves Amendment #5 to the FY 2023-24 GFDR Fund Balance which includes the following new GFDR allocations and adjusted GFDR Balance:

- 1. GFDR allocation in the amount of \$55,000 for legal contract services with Civica and Telecom.
- 2. GFDR allocation in the amount of \$60,000 for economic development master plan.
- 3. GFDR allocation of \$5,278,923 to provide future one-time budget balancing measures for fiscal years 2025-2027.
- 4. Adjusted/actual sale proceeds from sale of land located on Vale Road in the amount of \$3,045,923.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo approves Amendment #5 to the General Fund Designated Reserves with a total balance of \$7,601,598 for Fiscal Year 2023-24, effective January 16, 2024, as shown below:
