

RESOLUTION 2019-052

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING (1) THE TEMPORARY CLOSURE OF THE STREETS FOR THE 2019 CINCO DE MAYO PEACE & UNITY PARADE AND ST. PAUL'S FESTIVAL; (2) WAIVER OF TRAFFIC CONTROL FEES; (3) PROVISION OF POLICE, RECREATION AND PUBLIC WORKS STAFF TO SUPPORT EVENT; (4) PROVISION OF A \$7,000 EVENT SPONSORSHIP; AND (5) DESIGNATION OF THE CITY OF SAN PABLO-MANZANILLO SISTER CITY COMMITTEE AS FISCAL AGENT

WHEREAS, the *Cinco de Mayo Celebration* is an adopted policy item contained in the FY 2018-21 City Council Priority Work plan, effective March 1, 2019;

WHEREAS, community members from the City of San Pablo and the City of Richmond formed a Cinco de Mayo Parade "Event Committee";

WHEREAS, the Event Committee has coordinated the 2019 Cinco de Mayo Parade to be held on Saturday, May 4, 2019 starting at 10:00 a.m.;

WHEREAS, in order to accommodate the 2019 Cinco de Mayo Parade, the temporary closure of a portion of 23rd Street in San Pablo and Market Avenue is required;

WHEREAS, to accommodate increased pedestrians walking to the St. Paul's Church celebration, a temporary closure of Dover Avenue adjacent to the church is required;

WHEREAS, it is necessary to close a section of 23rd Street, between Market Avenue and Dover Avenue, to store horse trailers during the parade;

WHEREAS, the City received a written request from the Event Committee Co-Chairs dated February 7, 2019 that outlined the details of being a major sponsor for the event in which the Co-Chairs were seeking for the City of San Pablo's continued support and ongoing sponsorship for celebrating this event;

WHEREAS, the Cinco de Mayo Parade Committee requests a waiver of all related traffic control fees and requests \$7,000 for event sponsorship, none of which will be used for religious purposes; and

WHEREAS, funding of \$30,000 has been allocated out of the Major Community Events Funding Account under the adopted FY 2018-21 Quadrennial Budget (100-1110-44050-CIN-CO1), including a direct sponsorship payment of \$7,000 and \$23,000 of in-kind City services (i.e. Police, Public Works, and Community Services staff) in support of the 2019 Cinco de Mayo Annual event.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of San Pablo that the temporary closure of a portion of San Pablo's 23rd Street, Market Avenue and Dover Avenue as directed by the Chief of Police is hereby authorized; and

BE IT FURTHER RESOLVED that the City Council authorizes (1) waiver of traffic control fees for the 2019 Cinco de Mayo Peace & Unity Parade and St. Paul's festival; (2) provision of Police, Recreation and Public Works staff to support the event at no cost, but valued at approximately \$23,000; (3) provision of a \$7,000 of event sponsorship with no funds used for religious purposes; and (4) designation of the City of San Pablo-Manzanillo Sister City Committee as Fiscal Agent for the funds.
