## RESOLUTION 2024-

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO APPROVING AND AUTHORIZING THE EXECUTION OF COOPERATIVE AGREEMENT NO. 07W.08 WITH THE CONTRA COSTA TRANSPORTATION AUTHORITY TO OUTLINE THE ROLES AND RESPONSIBILITIES FOR PHASE 2 OF THE I-80 / SAN PABLO DAM ROAD INTERCHANGE PROJECT

WHEREAS, in June 2006, the Contra Costa Transportation Authority (Authority) entered into Cooperative Agreement No. 07W.01 (Agreement) with the City of San Pablo (City) to complete the Project Approval / Environmental Document phase for the I-80 / San Pablo Dam Road Interchange Project (Project);

WHEREAS, in 2013 due to the Project size and available funding, the Project was split into two (2) phases following the advancement of the design for the entire Project to the 65% Plans, Specifications, and Estimate stage;

WHEREAS, the Authority accepted the construction work for Phase 1 of the Project in July of 2018 at a total cost of \$42.5 million;

WHEREAS, Phase 1 of the Project included the relocated El Portal Drive on-ramp to westbound I-80, an extended auxiliary lane along westbound I-80 between the San Pablo Dam Road off-ramp and El Portal Drive on-ramp, and a reconstructed Riverside Avenue pedestrian overcrossing;

WHEREAS, a new cooperative agreement is needed to outline the roles and responsibilities of each agency for the implementation of Phase 2 of the Project; and

WHEREAS, Phase 2 of the Project is currently estimated to cost \$112 million with the construction phase still having a funding shortfall of \$88 million.

NOW, THEREFORE, the City Council of the City of San Pablo does hereby resolve as follows:

<u>Section 1</u>. <u>Recitals</u>. The Recitals set for above are true and correct and incorporated herein.

Section 2. Approval of Cooperative Agreement 07W.08. The City Council hereby approves Cooperative Agreement 07W.08 with the Authority in the form attached to the staff report accompanying this resolution, and the City Council hereby authorizes the Mayor and/or the City Manager to execute Cooperative Agreement 07W.08 on behalf of the City, and to make such changes or additions thereto with the concurrence of the City Attorney as are necessary or appropriate and which do no substantially alter the rights and obligations of the City thereunder. The Mayor and/or the City Manager are further authorized to execute such other documents and take such actions as are necessary to carry out and implement the obligations of the City under Cooperative Agreement 07W.08.
