RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) APPROVING THE CONTRA COSTA CLEAN WATER PROGRAM (CCCWP) INSPECTION ACTIVITIES AGREEMENT BETWEEN THE WEST COUNTY WASTEWATER DISTRICT, THE CONTRA COSTA FLOOD CONTROL AND WATER CONSERVATION DISTRICT, AND THE CITY OF SAN PABLO FOR THE INSPECTION OF CERTAIN INDUSTRIAL AND COMMERCIAL BUSINESSES IN ACCORDANCE WITH THE CITY'S MUNICIPAL REGIONAL STORMWATER NPDES PERMIT; AND (2) AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT

WHEREAS, the City's Municipal Regional Stormwater NPDES Permit, NPDES Permit No. CAS612008 ("Municipal Regional Permit") requires the City of San Pablo, as a permittee, to conduct inspections of certain industrial and commercial businesses as part of its municipal stormwater program;

WHEREAS, the West County Wastewater District ("Inspection Agency") also conducts inspections of certain industrial and commercial businesses as part of its wastewater regulatory obligations;

WHEREAS, efficiencies can be achieved by having the Inspection Agency conduct stormwater inspections on behalf of the City concurrently with the Inspection Agency's wastewater inspections, which benefits the City of San Pablo and its regulated businesses;

WHEREAS, the Contra Costa Flood Control and Water Conservation District ("District") provides administrative support and funding for the inspections;

WHEREAS, the District, the Inspection Agency, and City of San Pablo have been coordinating inspections in a similar manner since 2009; and

WHEREAS, the City of San Pablo desires to continue the inspection program with the District and the Inspection Agency under a new agreement among the three parties.

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of San Pablo hereby approves the Contra Costa Clean Water Program Inspection Activities Agreement between the District, the Inspection Agency, and the City of San Pablo;

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to execute the Contra Costa Clean Water Program Inspection Activities Agreement in a form to be approved by the City Attorney that does not substantially alter the City's rights or responsibilities from those set forth in the attached draft agreement; and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
