My name is Joshua Kerns and I live at [REDACTED] in the city of San Pablo.

I received an email, dated the 22<sup>nd</sup> of September 2024, from the Targeted Justice Newsletter. The email contained the following statements:

**“A targeted individual is someone selected by the Deep State, usually the FBI, Department of Homeland Security, or the CIA, to unwillingly participate in an experimental CIA torture program. This program was developed under the CIA’s MK-Ultra project and is designed to break down the individual and “neutralize the person,” using psychological, physical, and emotional stress.**

**The ultimate goal of this program is to control the entire population, through intimidation, fear, and threats. Political activists, Labor union leaders, scientists, and whistleblowers are some of the main targets of the program; however, some people are randomly chosen.**

**Family and spousal relationships are usually destroyed, as part of this psychological torture.”**

Prior to receiving this email, I had spent time researching phenomena which may in fact be related to the CIA’s torture program mentioned in the email I received.

PROJECT MKULTRA, according to a Freedom Of Information Act document on the CIA’s website was the code name for a covert CIA mind-control and chemical interrogation research program. This program, which began in the early 1950’s, was run by the Office of Scientific Intelligence, and supposedly used United States citizens as unwitting test subjects.

According to the book “Poisoner In Chief,” in the 1950s, here in the San Francisco Bay Area, the CIA sponsored subprojects at both Stanford and Berkeley. One psychiatrist, at Stanford alone, signed three MK-Ultra contracts. In addition to these Universities, or those with ties to these universities, during this same time frame, an investigator with the Federal Bureau of Narcotics, who was also an undercover CIA operative, set up a safe house in San Francisco, which would be used for MK-Ultra sub project 42, or what he called Operation Midnight Climax.

In addition to the events from the 1950’s, there are three documented cases, two of which I uncovered during my research, in the county of Contra Costa, in which persons claimed to be victims of phenomena similar to what a State Department security officer, who worked in the U.S. consulate in Guangzhou, China, claimed to have experienced during his interview regarding an investigation into Havana Syndrome. Havana Syndrome, or, as Dr. Len Ber with Targeted Justice mentions, is better described as NKBI, or rather non-kinetic brain injury, may in fact be related to the CIA torture program mentioned earlier.

Good Evening Members of the San Pablo City Council:
