

## **RESOLUTION 2026-###**

### **RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AFFIRMING RECOMMENDED CITY COUNCILMEMBER APPOINTMENTS BY MAYOR PABON-ALVARADO OF INDIVIDUAL CITY COUNCILMEMBERS TO ALL TEMPORARY AD-HOC SUBCOMMITTEES, STANDING COMMITTEES AND REGIONAL/LOCAL ASSIGNMENTS FOR CALENDAR YEAR 2026 PURSUANT TO SAN PABLO MUNICIPAL CODE SECTION 2.16.070**

WHEREAS, all City Councilmember assignments to newly established Temporary Ad-Hoc Subcommittees, Standing Committees, and Regional/Local Bodies for the upcoming Calendar Year 2026 (CY 2026) must be affirmed in accordance with San Pablo Municipal Code (SPMC) Section 2.16.070 requirements; and

WHEREAS, per SPMC Section 2.16.070 requirements, Mayor Pabon-Alvarado has made all recommendations of City Councilmembers to said City Council Standing Committees and Regional/Local Bodies for CY 2026 listed under Exhibits A and B attached hereto; and

WHEREAS, following City Council deliberation, the City Council agrees to establishment and re-constitution of all City Council Temporary Ad Hoc Subcommittees and Standing Committee changes listed under Exhibit A and B for CY 2026.

NOW THEREFORE, BE IT RESOLVED the City Council of the City of San Pablo hereby authorizes the following:

1. The Mayor has made all necessary recommendations for appointments of individual City Councilmembers to designated City Council Temporary Ad-Hoc Subcommittees, Standing Committees, and Regional/Local bodies for CY 2026 listed under Exhibits A and B attached hereto;
2. The City Council affirms establishment of all City Council Temporary Ad Hoc Subcommittees, Standing Committee, and Regional/Local bodies as listed under Exhibit A and B for CY 2026, attached hereto; and

3. The City Council affirms all individual City Councilmember appointments to the Temporary Ad-Hoc Subcommittees, Standing Committees, and Regional/Local bodies listed under Exhibit A and B for CY 2026 pursuant to SPMC Section 2.16.070 requirements.

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.
