

**RESOLUTION 2015-180**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ESTABLISHING MAXIMUM FEES FOR THE TOWING OF MOTOR VEHICLES PURSUANT TO CHAPTER 2.60 OF THE SAN PABLO MUNICIPAL CODE, AND SUPERSEDING RESOLUTION 2010-055**

WHEREAS, the City Council of the City of San Pablo last increased the fees for police requested motor vehicle tows in 2010;

WHEREAS, as required by Section 2.60.070, the City Council has considered the charges and rates prevalent in the city charged by towing companies for comparable services, and adopts the following maximum rates during the five year term of the upcoming tow agreements;

WHEREAS, upon adoption of these maximum rates the City Clerk is authorized to advertise for bids by towing operations who seek to contract with the City to provide official police towing services on a rotational basis;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of San Pablo that the maximum charges for motor vehicle towing services after the date of adoption of this resolution, pursuant to San Pablo Municipal Code Chapter 2.60, shall be in accordance with the following schedule which shall, upon its adoption, supersede the maximum fees set forth in Resolution 2010-055.


BE IT FURTHER RESOLVED that Resolution 2010-055 is hereby superseded.
