

RESOLUTION 2017-222

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE WAIVER OF FEES FOR USE OF EL PORTAL SOCCER FIELD AND RUMRILL SPORTS PARK PRACTICE FIELD AND A 2/3RD REDUCED FEE AT RUMRILL SPORTS PARK FOR FIELDS 1 AND 2 (TOTALING \$28,780) FOR THE SAN PABLO UNITED YOUTH SOCCER CLUB (SPUYSC) FOR THE 2018 SPRING SEASON

WHEREAS, *Healthy Eating Active Living: Low Cost Recreation Youth Programs for Income Sensitive Families AND Services for Families, Seniors & Youth: Capacity Building & Operating Space for Non-Profit Organizations* are adopted policy items under the FY 2017-21 City Council Priority Work plan, effective November 1, 2017;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, on November 30, 2017 Rafael Torres, President of SPUYSC, submitted a letter of request to the City Manager requesting the waiver of fees for El Portal Soccer Field and the new Rumrill Sports Park (Fields 1 & 2):

- El Portal field from March 12, 2018-June 29, 2018
 - Monday – Friday from 4:00 PM – 8:00 PM
 - Saturday and Sunday from 8:00 AM – 5:00 PM

- Rumrill Sports Park from January 3, 2018 – June 29, 2018
 - Monday – Friday from 5:00 PM – 8:00 PM
 - Saturday and Sunday from 8:00 AM – 5:00 PM; and

WHEREAS, SPUYSC is a volunteer-run, non-profit organization dedicated to the youth and families in the City of San Pablo to provide the opportunity to play soccer to approximately 200 boys and girls ages 3 to 18 years;

WHEREAS, through the sport of soccer, the SPUYSC has been able to increase active healthy participation for participants in an outdoor environment. SPUYSC has also been able to promote sportsmanship, leadership and teambuilding skills;

WHEREAS, The SPUYSC is attempting to reassure families that by being in partnership with the City of San Pablo that children will be protected regardless of their religion, race, gender, or immigration status and that no children are left behind due to socioeconomic disadvantages;

WHEREAS, there will be a full fee waiver for use of the El Portal Park Field as well as the practice field at Rumrill Sports Park with a 2/3rd fee waiver for Fields 1 and 2 at Rumrill Sports Park;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver; and

WHEREAS, the fiscal impact for FY 2018/19 (2018 spring season) will be subsidizing approximately \$22,920.00 in rental revenue for Rumrill Sports Park and \$5,860.00 for El Portal Park for a total subsidized amount of \$28,780.00.

NOW THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of the City of San Pablo authorizes the City Manager to waive the field rental fees for the San Pablo United Youth Soccer Club for the use of the El Portal Soccer Field and Rumrill Sports Park Practice Field and to waive 2/3rds of the fee for Rumrill Sports Park Fields 1 and 2 for a total of \$28,780 for the 2018 spring season.
