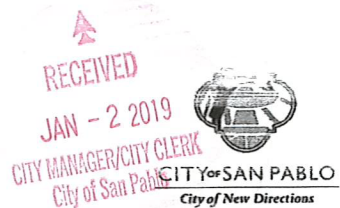



Served as a Mayor's Conference appointee to the East Bay Regional Communications System Authority.
