

**FIRST AMENDMENT TO MAINTENANCE AND TRADE SERVICES AGREEMENT
BETWEEN THE CITY OF SAN PABLO AND HERCULES TREE SERVICES &
LANDSCAPE CONSTRUCTION, INC. FOR ON-CALL TREE SERVICES**

THIS FIRST AMENDMENT TO MAINTENANCE AND TRADE SERVICES AGREEMENT FOR ON-CALL TREE SERVICES is effective the 3rd day of September, 2025, by and between the CITY OF SAN PABLO, a municipal corporation ("City") and Hercules Tree Service & Landscape Construction, Inc. ("Service Provider").

R E C I T A L S

WHEREAS, on March 19, 2024, CITY and Service Provider entered into a Maintenance and Trade Services Agreement for On-Call Tree Services in an amount not to exceed \$50,000 per fiscal year for five fiscal years and a total compensation amount not to exceed \$250,000 ("Agreement"); and

WHEREAS, the parties have agreed to modify the terms of that Agreement related to Section 2, "Compensation," to increase total compensation by \$200,000;

NOW, THEREFORE, THE PARTIES DO MUTUALLY AGREE AS FOLLOWS:

1. **COMPENSATION.** Section 2 of the Agreement, "Compensation," is amended to include the following provision(s):

"CITY shall pay Service Provider up to an additional **One Hundred Thousand Dollars (\$100,000)** for authorized On-Call Tree Services rendered during **Fiscal Year 2025/26**, and up to an additional **Fifty Thousand Dollars (\$50,000) per fiscal year** for authorized On-Call Tree Services over two (2) fiscal years, **Fiscal Year 2026/27 and Fiscal Year 2027/28**, for a total compensation under this contract as amended not to exceed **Four Hundred Fifty Thousand Dollars (\$450,000)**).

"On a completed deliverables basis, the total-not-to-exceed amounts per fiscal year of this Agreement shall be amended as follows:
