

## RESOLUTION 2021-108

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO RATIFYING THE WAIVER OF FEES FOR USE OF DAVIS PARK SPORTS FIELDS AND CONCESSION STAND FOR THE SAN PABLO COWBOYS YOUTH ASSOCIATION (SPCYA) FOR THE 2021 SUMMER / FALL SEASON

WHEREAS, *Expand Safe, Family-Friendly Park Space and Improve Connections to Healthy Eating and Active Living* are adopted priority items under the FY 2021-23 City Council Priority Workplan, effective March 15, 2021;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, On July 1, 2021 Andre Williams, President of SPCYA, submitted a letter to the City of San Pablo requesting the waiver of fees for Davis Park Multi-Use and Mini Sports Fields and the Davis Park Concession Stand for the following dates:

#### **Davis Park Sport Fields (Multi-Use Sports Field and Mini Sports Field)**

- July 21, 2021 – December 21, 2021
- Monday-Friday 6:30 pm-8:30 pm and Saturday – Sunday 10:00 am - 4:00 pm
- Exceptions include City Holidays/Closure Dates

#### **Davis Park Concession Stand**

- July 21, 2021 – December 21, 2021
- Monday-Friday 6:30 pm-8:30 pm and Saturday – Sunday 10:00 am - 4:00 pm
- Exceptions include City Holidays/Closure Dates

WHEREAS, the SPCYA offers a diverse football program that provides approximately 100 San Pablo youth the ability to travel to numerous cities and compete against various football programs. Participants are rewarded for their accomplishments in athletics as well as scholastics to assure them they are always winners just for taking the initiative to do their best;

WHEREAS, the resolution will result in a loss of rental income of approximately \$13,865 in General Fund rental revenues that the City could have realized for rental of the Davis Park Sport Fields and Concession Stand;

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of the City of San Pablo ratifies the waiver of field rental fees for the San Pablo Cowboys Youth Association for the use of the Davis Park Sports Fields and Concession Stand in the amount of \$13,865 for the 2021 summer/fall season.

BE IT FURTHER RESOLVED that as a condition of the fee waivers for use of the Davis Park Sport Fields:

1. A representative of the San Pablo Cowboys Youth Association must participate in at least two major City events in order to market their program, interact with the public and/or receive registrations for their program working with the City given the COVID pandemic precautions; and

2. Participants of the San Pablo Cowboys Youth Association who reside within the incorporated City of San Pablo boundaries receive a reduced registration rate compared to non-residents with the understanding that the San Pablo Cowboys Youth Association will provide staff with information about the reduced rates in the next six months with implementation to start January 1, 2022.
