

**SECOND AMENDMENT TO AGREEMENT FOR PROGRAM SERVICES BETWEEN THE CITY OF  
SAN PABLO AND YMCA OF THE EAST BAY**

**Agreement No. YA17-1007**

**THIS SECOND AMENDMENT TO AGREEMENT BETWEEN THE CITY OF SAN PABLO AND YMCA OF THE EAST BAY** for program services, is entered into this **1<sup>st</sup> day of July, 2019** by and between the City of San Pablo, a municipal corporation ("City ") and **YMCA of the East Bay** ("Agency").

**RECITALS:**

**WHEREAS**, on August 7, 2017, CITY and Agency entered into an Agreement for Agency to provide coordination of community schools under the San Pablo Community Schools Initiative ("Agreement"); and

**WHEREAS**, on October 16, 2017, CITY and Agency entered into the First Amendment to Agreement to pay Agency additional \$61,000 to efficiently manage program dollars for Lake and Bayview Elementary Schools to deliver Youth Leadership and Development program services at Lake and Violence Prevention and Intervention and Youth Leadership and Development programming at Bayview for a contract amount of \$211,000; and

**WHEREAS**, the Agreement contemplated that it could be extended for an additional two-year term and the parties have agreed to modify the terms of that Agreement related to compensation, term, and provider;

**NOW, THEREFORE, THE PARTIES DO MUTUALLY AGREE AS FOLLOWS:**

1. **COMPENSATION**, Section 2 of the Agreement, "Compensation" is amended to the following:

For fiscal years 2019-20 and 2020-21, in exchange for the satisfactory performance of services that satisfy and timely achieve the milestones, performance commitments and outcomes identified herein and in the attached exhibits, City hereby agrees to reimburse Agency on a "cost-of-service" basis, a sum not to exceed **Two Hundred and Twenty-Two Thousand Five Hundred Dollars and No Cents (\$222,500.00) per fiscal year, for a total of Four Hundred Forty Five Thousand Dollars and No Cents (\$445,000.00) and a total contract amount of Eight Hundred Sixty Seven Dollars and No Cents (\$867,000.00).**"

2. **TERM**, Section 4 of the Agreement, "Effective Date and Term" is amended to the following:

"The City has exercised the option to extend the term of the agreement to **June 30, 2021.**"

3. **PRIMARY PROVIDER**, Section 11 of the Agreement, "Designation of Primary Provider of Services" is amended to the following:

"The primary provider of the services called for by this agreement shall be **Theresa Dade-Boone**, who shall not be replaced without the written consent of City."

All other terms and conditions of the Agreement as may be amended, shall remain in full force and effect.
