RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) APPROVING AND ADOPTING THE PLANS AND SPECIFICATIONS FOR THE CITYWIDE TRASH CAPTURE DEVICE INSTALLATION PROJECT; (2) AWARDING A CONTRACT TO UNITED STORM WATER, INC.; (3) AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH UNITED STORM WATER, INC. IN THE AMOUNT OF \$145,558 WITH A 10% CONTINGENCY FOR A TOTAL AUTHORIZATION NOT TO EXCEED \$160,114.00 FOR THE PROJECT; AND (4) APPROPRIATING GENERAL FUND DESINATED RESERVES - NPDES MRP COMPLIANCE FACILITIES IMPROVEMENT FUNDS IN THE AMOUNT OF \$100,000 TO THE PROJECT BUDGET

WHEREAS, the Citywide Trash Capture Device Installation Project (0305) (Project) aims to meet the City's compliance requirements for provision C.10 of the National Pollutant Discharge Elimination System permit and fulfill the expectations outlined in the City's Long Term Trash Management Plan;

WHEREAS, the Project will be broken up into two phases. The first phase will install trash capture devices at storm drain inlets along Rumrill Boulevard to meet CNRA grant requirements for the Rumrill Complete Streets Project. The second phase will install, replace, and repair trash capture devices at other citywide storm drain locations;

WHEREAS, on April 11, 2024, the City advertised the Notice Inviting Bids and issued three addenda;

WHEREAS, on May 23, 2024, the City received one (1) bid and publicly opened the bid;

WHEREAS, United Storm Water, Inc. from Industry, California, submitted the only, apparent lowest responsive and responsible bid in the amount of \$145,558.00;

WHEREAS, the construction budget is as follows:
