RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH SPECTRASYSTEMS, INC. TO REPLACE POUR-IN-PLACE RUBBER PLAY SURFACE PADS AT DAVIS PARK IN THE AMOUNT OF \$50,668 WITH A 15% CONTINGENCY FOR A TOTAL AUTHORIZATION NOT TO EXCEED OF \$58,268

WHEREAS, the Public Works Department (PW) is responsible for the daily maintenance and upkeep of City properties and infrastructure including security, repairs, and major maintenance of City-owned assets such as building, landscaping, roadways, vehicles, and parks;

WHEREAS, PW has identified a need to replace the pour-in-place rubber play surface pads at Davis Park as part of the City's ongoing commitment to maintaining safe and accessible recreation facilities for the community;

WHEREAS, Davis Park features an outdoor playground equipped with pour-in-place rubber play surface pads that provide critical safety cushioning for children while using the playground equipment;

WHEREAS, over time, the rubber surface has deteriorated due to regular wear and tear from weather exposure, foot traffic, and general use, which has led to areas where the surface has become uneven, cracked, or has started to peel away, posing a potential safety risk to users and creating a less inviting play environment;

WHEREAS, staff has conducted a thorough inspection of Davis Park, and it has been determined that replacement of the rubber play surfaces is necessary to ensure the safety of park users and the longevity of the playground;

WHEREAS, replacing the rubber surface at Davis Park aligns with the City's efforts to enhance the safety and usability of its parks and recreation spaces, and the new play surfaces will provide a more durable, safer environment for children and families, while also ensuring compliance with industry safety standards; and

WHEREAS, PW staff recommends that Council authorize the City Manager to execute an agreement with Spectrasystems, Inc. to replace pour-in-place rubber play surface pads at Davis Park in the amount of \$50,668 with a 15% contingency in the amount of \$7,600 for a total authorization not to exceed amount of \$58,268.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo herby authorizes the City Manager to execute an agreement with Spectrasystems, Inc., in a form to be approved by the City Attorney that does not substantially alter the City's rights or responsibilities from those set forth in the attached draft agreement, to replace pour-in-place rubber play surface pads at Davis Park in the amount of \$50,668 with a 15% contingency in the amount of \$7,600, to be paid from FY 2024-25 PW Operating Budgets (Funds 100-3410-43600 and 237-3610-43600), for a total authorization not to exceed amount of \$58,268; and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
