### CITY OF SAN PABLO NOTICE OF PROPOSED TOBACCO REGULATIONS

NOTICE IS HEREBY GIVEN that the City Council of the City of San Pablo, State of California, will consider the following item at the City Council meeting on November 5, 2018:

**PLAN1807-0012, Amendment to Section 5.06 of the City of San Pablo Municipal Code to ban the citywide sale of flavored tobacco, including menthol and e-cigarette cartridges, and establishing a minimum pack size for cigars, cigarillos, and little cigars.** Consideration to amend Section 5.06 of the City of San Pablo Municipal Code, Licensure of Tobacco Products, to prohibit the citywide sale of flavored tobacco (including menthol and e-cigarette cartridges), and establish a minimum pack size for cigars (6 per pack, or \$10.00 per cigar), cigarillos (25 per pack) and little cigars (20 per pack).

The meeting will be held at the hour of 6:00 p.m. in the City Council Chambers located at One Alvarado Square, 13831 San Pablo Avenue, San Pablo, CA. 94806 at which time and place all persons interested may appear and comment.
