NOTICE IS HEREBY GIVEN: that the City Council of the City of San Pablo, State of California, will hold a Public Hearing in the Council Chambers of the City of San Pablo, 1000 Gateway Avenue, San Pablo, Ca 94806, on Monday, November 17, 2025, at 6:00 PM to consider and act upon the following:

Conduct public hearing and approve resolution of the City Council of the City of San Pablo adopting an updated City of San Pablo master fee schedule for planning, building, public works, community services, and other administrative fees; and consider adopting an annual bureau of labor statistics employment cost index adjustment to maintain fees relative to inflation as recommended in the Willdan Financial Consulting Group fee study to be applied prior to January 1, 2026 and prior to July 1st of each fiscal year thereafter.

Said public hearing shall be held in the Council Chambers of the City of San Pablo, City Hall, 1000 Gateway Avenue, San Pablo, California. All interested parties may submit written and oral objections to this proposed action. Written objections must be received by the City Clerk, 1000 Gateway Boulevard, San Pablo, CA 94806, by 2:00 pm on Monday, November 17, 2025. All objections will be considered and interested parties will be afforded an adequate opportunity to be heard.
