Assistant Planner Dempsey provided the presentation. A request for approval of Major Design Review for the construction of a new 25,549-square-foot industrial building with 42 off-street surface parking spaces, along with a Minor Adjustment for an increase in fence height from six feet to eight feet and a parking requirement

reduction of ten percent due to proximity to a transit stop, to be located on two adjacent parcels located at 1701 Rumrill Boulevard. The project includes a single-story warehouse and manufacturing building, 31 feet and 3 inches in height, built for the warehousing and assembly of commercial refrigeration units. The public hearing was opened at 6:34 p.m. Applicant/Owner Ben Plant agreed to Resolution PC25-13 along with conditions of approval. Commissioners asked clarifying questions of the applicant. The public hearing was closed at 6:42 p.m. A motion was made by Commissioner Owens to adopt Resolution PC25-13, seconded by Vice Chair Morris. The motion was approved as follows:
