

## RESOLUTION 2018-160

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A FEE WAIVER IN THE AMOUNT OF \$16,440 FOR THE SAN PABLO BASEBALL ASSOCIATION (SPBA) USE OF DAVIS PARK SPORTS FIELDS AND CONCESSION STAND FOR THE 2019 SPRING SEASON

WHEREAS, *Healthy Eating Active Living: Low Cost Recreation Youth Programs for Income Sensitive Residents: Capacity Building & Operating Space for Non-Profits/Community Organizations* are adopted policy items under the FY 2018-21 City Council Priority Work plan, effective November 1, 2017;

WHEREAS, on November 30, 2018 Andre Williams, President of SPBA, submitted a letter of request to the City Council requesting the waiver of fees for Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field) and the Davis Park Concession Stand on the following dates and times:

#### **Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field)**

- March 1, 2019 – June 30, 2019 on Monday - Friday
  - 4:00 PM - 8:00 PM
- March 1, 2019 – June 30, 2019 on Saturday - Sunday
  - 8:00 AM - 9:00 PM

#### **Davis Park Concession Stand**

- March 1, 2019 – June 30, 2019 on Monday - Friday

WHEREAS, SPBA has operated a volunteer-based youth baseball program in the City of San Pablo since 1955. This SPBA is a non-profit youth organization designed to help keep youth ages 4-16 off the streets by providing them with a safe, structured, adult supervised youth baseball program;

WHEREAS, according to the SPBA current rosters, they have approximately 75 youth athletes enrolled in their program. Of those 75 enrollees, 44% or 33 of those youth athletes reside in the City of San Pablo;

WHEREAS, organizations requesting fee waivers need to submit supporting paperwork such as articles of incorporation, updated roster/membership, list of organization officers and contact information, certificate of insurance, and copy of the organizations by-laws;

WHEREAS, the fiscal impact for the FY 2018/19 (2019 spring season) will be a subsidy of approximately \$16,440 in rental revenue for Davis Park Sport Fields and Concession Stand;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver; and

WHEREAS, this is not a project as defined by CEQA.

NOW THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of San Pablo authorizes the City Manager to waive the field rental fees of \$16,440 for the San Pablo Baseball Association for the use of the Davis Park Fields and Concession Stand for the 2019 spring season.
