RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ACCEPTING ADDITIONAL GRANT FUNDS FROM THE STATE COASTAL CONSERVANCY IN THE AMOUNT OF \$150,000 AND APPROPRIATING THOSE FUNDS INTO THE RUMRILL BOULEVARD COMPLETE STREETS PROJECT (0700)

WHEREAS, the Rumrill Boulevard. Complete Streets Project ("Project") is a major City project that proposes to modify Rumrill Boulevard to add Class IV bikeways or cycle tracks in both directions of travel, while reducing the number of vehicle travel lanes in both directions; and

WHEREAS, the Project also includes landscaped buffers; parking protection; striped buffers; physical barriers such as landscaping and curbing; traffic signal modifications; improved crosswalks; lighting and concrete improvements; flashing beacons and storm drainage improvements; and

WHEREAS, this Project also links the Wildcat Creek Trail to the Bay Trail at access points where changes to asphalt transitions and repair to trail surfaces are necessary; and

WHEREAS, this project was determined to be categorically exempt under the California Environmental Quality Act and the National Environmental Policy Act; and

WHEREAS, on November 2, 2020 through Resolution 2020-134, City Council approved the award of grant funds from State Coastal Conservancy (SCC); and

WHEREAS on June 7, 2021 through Resolution 2021-065, the grant funds were appropriated to the Rumrill Boulevard Complete Streets Project (0700); and

WHEREAS, on June 22, 2023 Public Works applied to the SCC for augmentation funding for this grant; and

WHEREAS, on July 19, 2023 the City was notified by SCC that the augmentation had been approved; and

WHEREAS, staff recommends accepting the augmentation funds from SCC in the amount of \$150,000 and appropriating the funds to be used for the Rumrill Boulevard Complete Streets Project (0700).

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo accepts the augmentation funds from SCC for the Rumrill Boulevard Complete Streets Project (0700) in the amount of \$150,000;
