- 1). Authorize the City Manager/staff to prioritize implementation of existing adopted rental housing regulation policies/programs contained in the adopted FY 2025-27 Council Priority Workplan (updated as of April 7, 2025); and
- 2). Authorize the City Manager/staff to prioritize the implementation of all 56 Housing Action Plan programs identified under the City's Housing Element certified by State HCD in March 2024; and
- 3). Authorize the City Manager/staff to prioritize seeking additional General Fund budget capacity and support for the existing rental housing regulations adopted in the FY 2025-27 Council Priority Workplan (as of April 7, 2027), as follows: Residential Health & Safety Inspection Program, Rent Registry, Mediation, and Tenant Relocation Assistance
- A). Direct the City Manager to submit and draft an amendment to the FY 2025-27 Council Priority Workplan to meet and partner with established housing policy experts and impacted stakeholders (i.e. CCAR, ACCE, Rising Juntos, CAA, California YIMBY, etc.) to enhance community awareness, education and outreach on rental regulations and rent stabilization, including but not limited to the following:

AB 1482 California Tenant Protection Act (ACCE Supported) Education and Awareness

Tenants' Rights and Responsibilities

Home Ownership Opportunities with SPEDC Programs

**Housing Counseling and Tenant Legal Services** 

**Cost-Neutral Rental Regulations and Rent Stabilization Policies** 

Community polling of community at-large and electorate on rental regulations and rent stabilization with Strategy Research Institute (SRI, Inc.)
