RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) AUTHORIZING SUBMISSION OF THE CITY OF SAN PABLO'S GRANT APPLICATION TO THE CALTRANS COMMUNITY CLEANUP AND EMPLOYMENT PATHWAYS GRANTS FOR LITTER ABATEMENT PROGRAMS AND WORKFORCE DEVELOPMENT FOR APPROXIMATELY \$120,000; AND (2) AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT APPLICATION AND TO TAKE OTHER NECESSARY ACTIONS TO RECEIVE SUCH GRANT FUNDING

WHEREAS, the California Department of Transportation (Caltrans) is currently accepting applications for the Community Cleanup and Employment Pathway (CCEP) Grant Program, a key initiative under the Clean California Program;

WHEREAS, the CCEP Program provides competitive grants to support litter abatement, community outreach, and workforce development efforts;

WHEREAS, the City of San Pablo has a need to address litter and workforce development as part of the City's National Pollutant Discharge Elimination System (NPDES) permit requirements;

WHEREAS, Identify and Implement Long-Term Environmental Stewardship Goals is an adopted policy item under the FY 2025-27 Council Priority Workplan;

WHEREAS, the San Pablo Public Works Department has two programs, the Neighborhood Champions Program and the partnership with SOS Richmond, that could be expanded and enhanced with this funding;

WHEREAS, the City of San Pablo is eligible to apply and receive funding from the CCEP Program; and

WHEREAS, the Public Works Department recommends a proposed application submission for the CCEP grant program of approximately \$120,000.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby authorizes the submission of the City of San Pablo's grant application to the California Department of Transportation (Caltrans) for the Community Cleanup and Employment Pathway (CCEP) Grant Program;
