RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE A FIVE-YEAR AGREEMENT WITH 101VOICE FOR HOSTED VOIP TELECOMMUNICATIONS SERVICES IN AN AMOUNT OF \$821.26 IN ONE TIME IMPLEMENTATION COSTS, AND \$2,470.93 IN MONTHLY COSTS FOR A TOTAL COST OF \$149,286 OVER A FIVE-YEAR PERIOD

WHEREAS, *Strengthen Existing and New Technology Programs, Public Facility/Infrastructure Projects, and Future Workplace Development Programs/Services to Enhance SPPD Crime-Reduction Goals, Community Policing, Mental Health, and Training Programs* is an adopted policy item under the FY 2025-27 City Council Priority Workplan, adopted April 7, 2025;

WHEREAS, the City has been using 101VOICE hosted Voice over Internet Protocol (VOIP) telecommunications services since 2021 and the system has proven reliable, cost-effective, and has provided enhanced functionality for City staff;

WHEREAS, the previous three-year contract with 101VOICE expired in 2024 and City IT staff have evaluated the service and determined that it continues to meet the City's telecommunications needs;

WHEREAS, staff recommend entering into a renewal agreement with 101VOICE to continue with the hosted VOIP service;

WHEREAS, this purchase is in accordance with City of San Pablo Municipal Code Chapter 3.16, pursuant to the cooperative purchasing exemption in Section 3.16.110(E), which allows the City to join with other governmental agencies for the joint purchase of equipment, materials, supplies and services or to buy from another public agency's competitive contract without the City undertaking its own competitive bidding process;

WHEREAS, the California Multiple Award Schedules (CMAS) offers a wide variety of commodity IT products and services at prices which have been assessed to be fair, reasonable, and competitive;

WHEREAS, IT Management Corporation has a CMAS Contract (3-24-05-1063) that is valid from May 28, 2024, through May 31, 2027, for the sale of 101VOICE hosted VOIP services and telecommunications systems; and

WHEREAS, the total cost of the five-year 101VOICE telecommunications service agreement is \$149,286.46, comprised of a one-time implementation cost of \$821.26 and monthly recurring charges of \$2,474.42 (including taxes and fees) for 60 months, to be charged to the City's Multi Department communications account (100-1430-42001).

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to execute a five-year agreement with 101VOICE in an amount of \$149,286 for hosted VOIP service through the CMAS Contract (#3-24-05-1063); and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct and are included herein by reference as findings.
