RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE A FIVE (5) YEAR AGREEMENT WITH SWEEPING CORPORATION OF AMERICA (SCA) FOR CITYWIDE STREET SWEEPING SERVICES IN AN AMOUNT NOT TO EXCEED \$180,000 FOR FISCAL YEAR 2023/24 AND A TOTAL AUTHORIZATION AMOUNT NOT TO EXCEED \$994,614 THROUGH FISCAL YEAR 2027/28

WHEREAS, the City of San Pablo requires street sweeping services for all City streets; and

WHEREAS, the City has solicited public bids for street sweeping services in conformance with the Request for Proposal (RFP), and on February 23, 2023, three (3) sealed bids were received and opened as follows; and

WHEREAS, the RFP stated that to the City would select the best qualified proposer and not necessarily the lowest bidder; and

WHEREAS, the City Staff performed a thorough review and evaluation of the proposals, qualifications and references, and recommends Sweeping Corporation of America (SCA), San Jose, California, with a bid in the amount of \$180,000; and

WHEREAS, the proposed resolution authorizes the City Manager to enter into a 5 year agreement with SCA (Agreement); and

WHEREAS, the agreement includes an annual price escalator based on the U.S. Bureau of Labor Statistics, Consumer Price Index, San Francisco Area, with a minimum annual increase of three percent (3.0%) and a maximum annual increase of five percent (5.0%); and

WHEREAS, funding in the amount of \$180,000 for services in Fiscal Year 2023/24 is available from the adopted Fiscal Year 2023/24 Public Works Street Maintenance Operating Budget (200-3710-43600) and funding for the remaining four years will be subject to future budget approval by the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby awards the street sweeping services contract to Sweeping Corporation of

America, LLC and authorizes the City Manager to execute a five (5) year agreement with Sweeping Corporation of America, LLC in an amount not to exceed Nine Hundred Ninety-Four Thousand Six Hundred Fourteen Dollars (\$994,614) as follows:.
