

RESOLUTION 2019-064

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO TO ACCEPT AND APPROPRIATE THE HIGHWAY BRIDGE PROGRAM GRANT IN THE AMOUNT OF \$389,196 FROM THE CALIFORNIA DEPARTMENT OF TRANSPORTATION AND TO APPROPRIATE \$5,735 FROM THE FY 2018/19 GENERAL FUND DESIGNATED RESERVES TO THE GIANT ROAD BRIDGE REPAIR PROJECT (SPC-GAV)

WHEREAS, Caltrans routinely inspects City owned bridges in San Pablo as part of a Federal Highway Act requirement for the State to be eligible for federal assistance;

WHEREAS, bridges are inspected and rated to indicate any deficiencies including structural adequacy and overall condition;

WHEREAS, bridges rated as structurally deficient and/or functionally obsolete are eligible for federal assistance through the Highway Bridge Program to replace and/or rehabilitate deficient locally owned public bridges;

WHEREAS, the Giant Highway Bridge (State Bridge No. 28C0326) over San Pablo Creek was built in 1981 and was deemed by a recent Caltrans to be structurally deficient and eligible for deck and joint replacement;

WHEREAS, in 2016, City staff submitted a grant application to repair the Giant Highway Bridge under the Highway Bridge Program (HBP) administered by the Caltrans and was awarded \$389,196 in grant funding to replace the deck methacrylate and the bridge joints;

WHEREAS, a grant match of \$11.47% is required for this grant program and pursuant to Resolution 2019-017, a grant match requirement for the Preliminary Design phase in the amount of \$5,735 is available under the FY 2018/19 General Fund Designated Reserves;

WHEREAS, at this time, staff recommends the acceptance and appropriation of the grant funds and the appropriation of the Preliminary Design grant match requirement to the Giant Road Bridge Repair Project; and

WHEREAS, a grant match in the amount of \$44,689 is needed for the Construction phase and staff will return to appropriate the required grant match at a later date.

NOW THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to (1) accept grant revenues from a Caltrans Highway Bridge Program Grant in the amount of \$389,196 into the Giant Road Bridge Repair Project (320-3201-33403-SPC-GAV) and appropriate said funding to the same Project (320-3201-43600-SPC-GAV); and

(2) appropriate a grant requirement for the Preliminary Design phase in the amount of \$5,735 from the FY 2018/19 General Fund Designated Reserves / Fordham & El Portal Stabilization/Repairs to the Giant Road Bridge Repair Project (320-3200-43600-SPC-GAV).
