RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A FEE WAIVER IN THE AMOUNT OF \$18,640 FOR THE SAN PABLO BASEBALL ASSOCIATION (SPBA) USE OF DAVIS PARK SPORTS FIELDS AND CONCESSION STAND FOR THE 2018 SPRING SEASON

WHEREAS, *Healthy Eating Active Living: Low Cost Recreation Youth Programs for Income Sensitive Families AND Services for Families, Seniors & Youth: Capacity Building & Operating Space for Non-Profit Organizations* are adopted policy items under the FY 2018-21 City Council Priority Work plan, effective November 1, 2017;

WHEREAS, on November 22, 2017 Andre Williams, President of SPBA, submitted a letter of request to the City Council requesting the waiver of fees for Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field) and the Davis Park Concession Stand on the following dates and times:

Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field)

- February 1, 2018 - July 12, 2018 on Monday - Friday
 - 4:00 PM - 8:00 PM
- February 1, 2018 - July 12, 2018 on Saturday - Sunday
 - 8:00 AM - 7:00 PM

Davis Park Concession Stand

- February 1, 2018 - July 12, 2018 on Monday - Friday
 - 8:00 AM - 7:00 PM

WHEREAS, SPBA has operated a volunteer-based youth baseball program in the City of San Pablo since 1955. This SPBA is a non-profit youth organization designed to help keep youth ages 4-16 off the streets by providing them with a safe, structured, adult supervised youth baseball program;

WHEREAS, the fiscal impact for FY 2018/19 (2018 spring season) will be subsidizing approximately \$18,640 in rental revenue for Davis Park Sport Fields and Concession Stand;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver; and

WHEREAS, this is not a project as defined by CEQA.

NOW THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of San Pablo authorizes the City Manager to waive the field rental fees for the San Pablo Baseball Association for the use of the Davis Park Fields and Concession Stand for the 2018 spring season in the amounts set forth above.
