RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO APPROVING FY 2018/19 FINAL GRANT AWARDS FOR THE ANNUAL SAN PABLO COMMUNITY FOUNDATION GRANT PROGRAM – (GROUP C)

WHEREAS, the City Council adopted *Community Grant Program – Non-Profits 501 (c3) Funding – Special Events* as a policy item under the FY 2018-21 Council Adopted Workplan;

WHEREAS, the City Council has appropriated \$100,000 in discretionary funding as part of the FY 2018-21 Quadrennial Four-Year Adopted Budget under the City Council Departmental Budget (Account 100-1110-44050) to provide financial assistance to non-profit 501 (C3) organizations, and establishment of a FY 2018/19 Annual San Pablo Community Foundation Grant Program for period July 1, 2018 through June 30, 2019;

WHEREAS, on April 2, 2018, the City Council by previous Resolution 2018-046 has established program guidelines and adopted an administrative policy which establishes the proposed guidelines for the FY 2018/19 Annual San Pablo Community Foundation (SPCF) Grant Program for Non-Profit Community Service Organizations;

WHEREAS, following City Council approval, the City Manager finalized all SPCF grant application guidelines and officially announced the availability of the FY 2018/19 SPCF Grant Program application guidelines to the public on April 3, 2018, with a grant submittal deadline of May 1, 2018;

WHEREAS, on May 1, 2018, the City Manager received thirty-two (32) applications for FY 2018/19 funding consideration by the required deadline which totaled \$282,300 in funding requests for the FY 2018/19 grant program year;

WHEREAS, on June 6, 2018, upon review of all qualified applicants by the SPCF Grant Review Committee, a recommended list of seventeen (17) qualified applicants for FY 2018/19 funding consideration was determined, and forwarded to the City Council for review;

WHEREAS, following City Council review, the City Council acknowledged and reviewed a total of one (1) appeal letter from organizations requesting grant award funding consideration;

WHEREAS, City Council may hear appeal from the appellant and render an appropriate decision after Council deliberation per the Council's adopted policy; and the City Council may or may not change the grant recipients and amount of awards being recommended by the SPCF Grant Committee by majority vote via Resolution; and

WHEREAS, the City Council deliberated on the recommendations from the SPCF Grant Committee for award of grants;

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby authorizes the following grants and directs the City Manager to prepare disbursements to the following organizations by June 28, 2018:
