Coordinate and participate in all City Manager directed Emergency Preparedness and EOC activities during CY 2020 only

(5) COVID-19 PANDEMIC OPERATIONAL AND POLICY MATTERS:

Coordinate and participate in all City Manager directed COVID-19 operational or policy related matters during CY 2020 only

(CRUZ; PINEDA) (PROPOSED)

NOTE: Due to Ralph M. Brown Act regulations, state law requires Ad Hoc SubCommittees to be temporary in nature, project-specific, and must meet infrequently, and require a specific purpose or objective within specific duration (i.e. max. 1 year). All City Council Ad Hoc SubCommittees established by Resolution of the City Council must coincide with adopted policy items under the FY 2019-21 Council Priority Workplan and expire on December 31, 2020.
