During the meeting, the public may provide public comments via email to Pcommission@sanpabloca.gov, which will be read into the record before the Planning Commission's consideration of the item and will be limited to three (3) minutes. Comments that do not conform to the Planning Commission's rules of decorum may be summarized rather than read verbatim.
