## Minutes of the Regular Meeting of the San Pablo City Council

Monday, July 18, 2022

## **ROLL CALL**

The video/teleconferenced meeting convened at 6:00 pm. Present were Mayor Rita Xavier, Vice Mayor Abel Pineda and Councilmembers Patricia Ponce and Arturo Cruz. Absent was Elizabeth Pabon-Alvarado. Also present were Assistant City Manager Charles Ching, Acting City Attorney Clare Gibson, Police Chief Ron Raman, Public Works Director/City Engineer Allan Panganiban, Director of Finance Norm Veloso, Community Services Director Greg Dwyer, Community Development Director Libby Tyler, City Treasurer Viviana Toledo, City Clerk Dorothy Gantt, and Deputy City Clerk Lehny Corbin.

Mayor Xavier announced that the City Council previously determined to meet remotely pursuant to Assembly Bill 361, and that the Council's findings are memorialized in Consent Calendar item #6.

A pre-recorded announcement was played indicating that the meeting was being held via video/teleconference in accordance with the Brown Act as currently in effect under the Governor's Emergency Declaration related to COVID-19 that allow members of the City Council, City staff and the public to participate and conduct a meeting by teleconference, videoconference or both. The announcement indicated the ways in which members of the public may watch or listen to the meeting during livestream on the City website. Instructions were also announced that the public might provide public comments via email, which would be read before Council consideration of the item.

#### ORAL COMMUNICATIONS

City Clerk Gantt read aloud the comments submitted by:

- Cordell Hindler asking the City Council to invite Clifford Chan to update on restrictions of water use; and to invite Tim Hale for a presentation on electric charging stations;
- Caitlin Bracken spoke of the need to protect the environment and future of the planet.
- Lucy Alfaro, President of the Kiwanis Club of San Pablo seeking sponsorship from the City for their event on August 13, 2022, from 10:00 am to 3:00 pm, to help with the event.

# **PRESENTATIONS**

1. <u>Presentation to the City Council regarding the San Pablo Avenue Multimodal Corridor Study conducted by the West Contra Costa Transportation Advisory Committee</u>. (#22-300)

Assistant City Manager Ching introduced the item. Environmental Program Analyst Sarah Kolarik gave a brief introduction of the purpose of the study. Leah Greenblat of WCCTAC also spoke briefly regarding the study. Adam Dankberg of Kimley-Horn presented the San Pablo Avenue Multimodal Corridor Study Phase 2, including among other things, the Study Purpose and Process, Phase 1 Summary, Phase 2 Project Process, Corridor Conditions and Project Needs, BRT (Bus Rapid Transit) benefits, comparison of transit solutions, key takeaways, options on what to do next, and options for the decision makers.

Council expressed their comments and Ms. Kolarik, Mr. Dankberg and Ms. Greenblat addressed their concerns.

San Pablo resident Arturo Carrion commented on possible increased traffic impacts with the implementation of this study/plan.

2. Presentation to the City Council of the City's first Digital Budget Book for the recently-adopted Biennial Operating and CIP Budget for FY 2022-23 and FY 2023-24. (#22-303) Assistant City Manager Ching introduced the item. Director of Finance Veloso provided product information on the new interactive Digital Budget Book. Robbie Bendorf, Customer Success Manager for OpenGov, presented the City's goals and the current capabilities of the program. OpenGov's Associate Project Manager Tommi Gonzales gave an online demonstration of the Digital Budget Book on the City's website.

Council expressed their comments. San Pablo resident Jim McCarty commented on sorting capabilities of the City Website.

By adoption of the Consent Calendar, **Resolution 2022-112** was adopted, a Resolution of the City Council of the City of San Pablo, California, extending the existence of a local emergency due to Novel Coronavirus (COVID-19); determining that the City Council and other Brown Act bodies in the City of San Pablo continue to meet remotely through September 30, 2022 due to COVID-19 social distancing recommendations from the Contra Costa Health Department under Assembly Bill 361 Findings; and confirming the actions taken by the Director of Emergency Services.
