### Roll Call/Staff Introductions

Chair Feliciano called the teleconferenced/video-conferenced meeting to order at 6:08 p.m. Roll call showed present: Commissioner Morris, Commissioner Jackson, Commissioner Owens and Chair Feliciano. Vice Chair Gurdian was absent. Staff present at the meeting included: Libby Tyler, Community Development Director; Teresa Stricker, City Attorney; Mel Mackson, Planning Assistant; and Michelle Chavez, Administrative Secretary. Community Development Director Tyler announced that the meeting was being held via video/teleconference in accordance with the Brown Act as amended by Assembly Bill 361 and following a determination of the City Council pursuant to Resolution 2022-123 that all City Brown Act bodies continue to meet remotely through teleconference, videoconference or both. Ms. Tyler further announced the ways in which members of the public could watch or listen to the meeting during livestream on the City website, which were also highlighted in the Planning Commission's agenda. Instructions were also announced on how the public could provide public comments via email which would be read before consideration of the item.

### Public Hearing

File ID #PC22-22: Housing Element Update

Community Development Director Tyler and Dyett-Bhatia Principal Andrew Hill gave a joint presentation on the First Draft Housing Element. The First Draft Housing Element was posted on the City's website on August 19, 2022 for a public review period of 30 days. On September 19, 2022 the City Council will review the First Draft Housing Element and hold a public hearing. The First Draft Housing Element will be submitted to HCD (California Department of Housing and Community Development) by September 30, 2022 for a 90-day review. The Planning Commission and City Council will hold public hearings for final adoption in Spring of 2023. The public hearing opened at 6:51 pm and

closed at 6:52 pm as there were no public comments. Questions were made by Commissioners regarding the proximity of housing sites to industrial activities, readiness/feasibility of sites on the draft housing inventory, and anti-displacement measures in the First Draft Housing Element. A motion was made by Commissioner Morris and seconded by Commissioner Owens recommending City Council approval to send the First Draft Housing Element to HCD by September 30, 2022.
