### NOTICE OF PUBLIC HEARING TUESDAY, November 22, 2022

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of San Pablo, State of California, will hold a public hearing on the following item:

PLAN 2206-0005: A request from WSS, for approval of Major Design Review and a Variance for wall signage area to allow a one-story 10,000 square foot commercial retail shoe store at 13220 San Pablo Avenue, located in the San Pablo Avenue Specific Plan's Regional Commercial district, (APN 417-211-012). The requested Variance would include approval of two 96 square foot signs (211 percent increase) along the primary frontage (San Pablo Avenue), and one 96 square foot sign (153 percent increase) along the secondary frontage (Kirk Lane). The new pad building would be located within the existing parking lot at the northeast corner of San Pablo Avenue and Kirk Lane. The proposed project has been determined to be categorically exempt from the provisions of the California Environmental Quality Act (CEQA), in accordance with CEQA Guidelines pursuant to Section 15332, In-Fill Development Projects.

NOTICE IS HEREBY FURTHER GIVEN that the public hearing will be held at the Planning Commission meeting on Tuesday, the 22nd day of November 2022 at 6:00 p.m. Questions may be directed to the City of San Pablo Community Development Department at (510) 215-3030.
