

**FIRST AMENDMENT TO AGREEMENT TO LEGAL SERVICES AGREEMENT
BETWEEN THE CITY OF SAN PABLO AND TELECOM LAW FIRM PC**

THIS FIRST AMENDMENT TO LEGAL SERVICES AGREEMENT is effective this 15th day of February, 2024, by and between the CITY OF SAN PABLO, a municipal corporation ("City") and Telecom Law Firm PC ("Counsel").

R E C I T A L S

WHEREAS, on January 17th, City and Counsel entered into a Legal Services Agreement ("Agreement"); and

WHEREAS, the parties have agreed to modify the terms of that Agreement related to Section 2, "Compensation," Section 7.6, "COVID-19 Pandemic," and Section 10.9, "Notices;"

NOW, THEREFORE, THE PARTIES DO MUTUALLY AGREE AS FOLLOWS:

1. **COMPENSATION.** Section 2 of the Agreement, "Compensation," is amended to include the following provision:

"CITY shall pay Counsel up to an additional **Ten Thousand Dollars (\$10,000)**, for a total compensation not to exceed **Forty Thousand Dollars (\$40,000)**."

2. **COVID-19 PANDEMIC.** Section 7.6 of the Agreement, "COVID-19 Pandemic," is hereby amended and restated in its entirety to read as follows:

"All City of San Pablo programs and services must be in compliance with current health orders issued by Contra Costa County Health Services at: <https://www.coronavirus.cchealth.org/health-orders>. Consultant shall comply with these requirements and contact City staff immediately if there is any issue with compliance. In addition, the City requires all contractors/consultants providing services at City facilities or City worksites to comply with all City's current COVID policies on-site as they may be amended from time to time."

3. **NOTICES.** Section 10.9 of the Agreement, "Notices," shall be amended to include the following provision:
