

## **RESOLUTION 2016-211**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) REJECTING THE LOW BID OF VALLEY TRUCK AND TRACTOR; (2) AUTHORIZING THE PURCHASE OF (1) ONE JOHN DEERE Z930M COMMERCIAL MOWER FOR THE PUBLIC WORKS MAINTENANCE DIVISION FROM RDO EQUIPMENT IN THE AMOUNT OF \$8,609 WITH A 15% CONTINGENCY AUTHORIZATION AUTHORITY OF \$1292; (3) DECLARING A 2000 JOHN DEERE F680 FRONT MOWER AS SURPLUS PROPERTY; AND (4) APPROVING THE DISPOSAL OF SURPLUS PROPERTY**

WHEREAS, the replacement of equipment meets the Council Priority Work Plan item: Fiscal Sustainability (Budget Spending Controls), effective July 1, 2015;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, Valley Truck and Tractor submitted the lowest bid but was non-responsive for failing to sign the bid;

WHEREAS, RDO Equipment provided the next lowest bid for a Z930M Commercial Mower, for a purchase cost in the amount of \$8,609;

WHEREAS, the City's existing John Deere F680 Front Mower is 16 years old and has reached its end of life-cycle;

WHEREAS, John Deere is an industry leader that specializes in commercial landscape equipment;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby declares Public Works Maintenance Division's John Deere F680 Front Mower to be surplus and authorizes the Finance Manager to dispose of said surplus equipment, as set forth in San Pablo Municipal Code §3.16.120;

BE IT FURTHER RESOLVED that the City Council rejects the bid of Valley Truck and Tractor;

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to execute a contract with RDO Equipment for \$8,609 for the purchase of a Z930M Commercial Mower; and

BE IT FURTHER RESOLVED that funding in the amount of \$8,609, from the approved City of San Pablo FY 2015/16 Street Maintenance Budget for Equipment (200-3110-46300), is available for the purchase of a Z930M Commercial Mower, with an available fifteen percent contingency amount of \$1,292, for a total authorization amount of \$9,901.
