

## RESOLUTION 2017-060

### **RESOLUTION OF THE CITY COUNCIL OF THE CITY SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH BAJAN SECURITY TO PROVIDE SECURITY SERVICES AT RUMRILL SPORTS PARK FOR AN AMOUNT NOT TO EXCEED \$80,000**

WHEREAS, BNSF/Rumrill Sports Field Project and Adult/Youth Sports Programs are adopted policy items under the adopted FY 2015-17 Council Priority Workplan, effective October 1, 2016;

WHEREAS, in the summer of 2015, staff unanimously agreed that while there are security cameras and an emergency callbox located on site, it was imperative to provide some additional level of security at Rumrill Sports Park;

WHEREAS, staff initially conducted an informal bid process per Municipal Code Section 3.16.090 to research and interview numerous security agencies, eventually choosing to enter into an agreement with Bajan Security;

WHEREAS, the scope of work was to provide nightly security at Rumrill for the safety of patrons, the park/amenities itself, as well as to provide an additional presence in the area;

WHEREAS, in addition to providing later afternoon and nightly security on site at Rumrill, Bajan Security has also worked closely with our Police Department (who has increased patrols in the area as an additional safety measure);

WHEREAS, there have been some minor issues with enforcement of rules and regulations, as well as some occasions where the Bajan Security guard had to intervene to de-escalate an argument;

WHEREAS, staff feels that the presence of Bajan Security at the Rumrill Sports Park has provided the additional level of safety and security that was desired, they not only help to protect the amenities of the park but more importantly, have made our patrons feel safer in the park;

WHEREAS, given Bajan Security's familiarity with providing security at Rumrill Sports Park, staff is recommending to contract with Bajan Security to continue to provide security services at Rumrill Sports Park and that competitive bidding requirements provided for by statute may be dispensed with if the public interest is better served by doing so, as where competitive bidding would not produce an advantage. (*Graydon v. Pasadena Redevelopment Agency* (1980) 104 Cal.App.3d 631; *Los Angeles Dredging Co. v. Long Beach* (1930) 210 Cal.348.);

WHEREAS, this contract will be funded pending approval of the FY 2017/21 budget through the Recreation Professional Services account (100-5210-43600) in an amount not to exceed \$80,000;

WHEREAS, in order to further the City's interest in local workforce development, the Agreement requires Bajan Security to contact the San Pablo EDC (Economic Development Corporation) if it has employment vacancies for providing services under this Agreement, so that the EDC may refer any qualified and trained residents;

WHEREAS, this item was presented to the City Council Community Services Standing Committee on Tuesday, April 11, 2017 for their review. The Standing Committee supported the recommendation; and

WHEREAS, this is not a project as defined by CEQA.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings;

BE IT FURTHER RESOLVED the City Council of the City of San Pablo finds that continuing the agreement with Bajan Security without engaging in another competitive bid process at this time is in the best interests of the City because Bajan Security provided the lowest bid during an informal bidding process last year; the firm has been providing security at the facility since it opened and as such is uniquely familiar with the park and its issues; and staff will evaluate the need for and provision of these services during the coming year; and

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to execute an agreement with Bajan Security to provide security at Rumrill Sports Park for an amount not to exceed \$80,000.
