RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO ACCEPTING WORK PERFORMED BY GHILOTTI BROS, INC. FOR THE 2015/16 PAVEMENT REHABILITATION PROJECT (PAV-016) AND THE NORTH ARLINGTON BOULEVARD ROAD REHABILITATION PROJECT (NAR-EMR) AS COMPLETE AND DIRECTING THAT A NOTICE OF COMPLETION BE PREPARED AND FILED WITH THE COUNTY RECORDER

WHEREAS, the subject project is in the approved capital projects budget for the City of San Pablo (the "City");

WHEREAS, the Annual Pavement Maintenance Project consisted of but not limited to base failure repairs, slurry sealing, crack sealing, cold planning of existing asphalt concrete, overlaying existing asphalt concrete pavement with conventional asphalt concrete, constructing concrete curb ramps, placement of striping and installing valley gutter, installation of piers and grade beam;

WHEREAS, on June 6, 2016, the City awarded Ghilotti Bros., Inc. (GBI) of San Rafael, CA the contract for the Annual Pavement Maintenance Project in the amount of \$1,523,959;

WHEREAS, construction was completed on time with an additional increase of \$101,073.28, which is approximately 6.6% above the original contract amount including work on North Arlington Boulevard Road Rehabilitation (NAR-EMR) for a total of \$1.625.031.68:

WHEREAS, the Improvements were completed on May 9, 2017, in accordance with the plans and specifications;

WHEREAS, by adopting the attached Resolution, the City Council will accept the work as complete and authorize the City Engineer to issue a Notice of Completion; and

WHEREAS, the final cost of construction of the project is \$1,625,031.68 which amount is already budgeted and approved.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby finds that the foregoing recitations are true and correct, and hereby:

- Accepts work performed by Ghilotti Brothers, Inc. for the Annual Pavement Maintenance 2016 (PAV-016) and the North Arlington Boulevard Road Rehabilitation (NAR-EMR); and
- 2. Directs that a Notice of Completion for the Annual Pavement Maintenance 2016 (PAV-016) be prepared and filed with the County Recorder.
