RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO ENTER INTO AN CONSTRUCTION MANAGEMENT/ INSPECTION SERVICES AGREEMENT WITH PARK ENGINEERING, INC. FOR THE SAN PABLO AVENUE COMPLETE STREETS PROJECT IN THE AMOUNT OF \$610,696 WITH APPROXIMATELY 6.5% CONTINGENCY, FOR A TOTAL AUTHORIZATION OF \$650,466

WHEREAS, the San Pablo Avenue Complete Streets Project addresses a need for safe multimodal facilities on a major arterial, San Pablo Avenue between Rumrill Boulevard in the City of San Pablo and Hilltop Drive in the City of Richmond;

WHEREAS, in 2013, the City of San Pablo submitted an application to the Metropolitan Transportation Commission (MTC) for \$5,978,000 in funding;

WHEREAS, City of San Pablo was awarded \$5.978 million in One Bay Area Grant (OBAG) funds for the San Pablo Avenue Complete Streets Project while the design and environmental review and construction management/inspection are jointly funded by the City of San Pablo and the City of Richmond, each contributing \$615,000;

WHEREAS, Resolution 2015-058 approved the grant matching funds in the amount of \$1,230,000 jointed funded by the City of San Pablo and the City of Richmond for the San Pablo Avenue Complete Streets Project;

WHEREAS, the City released a Request for Proposal and Statement of Qualifications (RFP/SOQ) on June 27, 2017 for construction management/inspection services per Caltrans Local Assistance Procedures Manual and Section 3.16.110 of the Municipal Code for Architecture and Engineering services;

WHEREAS, following a thorough review and evaluation of consultant qualifications, references and subsequent interviews, Park Engineering Inc. was selected to provide the requested services;

WHEREAS, Resolution 2015-105 approved the funding allocation in the amount of \$579,534 to the BKF Engineers for Design and Environmental Review;

WHEREAS, the remaining available budget in the amount of the \$650,466 will fund the Park Engineering Inc. Construction Management/Inspection Services agreement; and

WHEREAS, funding in the amount of \$650,466, which would allow a 6.5 percent contingency, is available from the FY17/18 Capital Improvement Program for the San Pablo Complete Streets Project (320-3200-43600-SPA-CST).

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to enter into an agreement with Park Engineering in an amount up to \$650,466, which would allow for a 6.5 percent contingency, to provide construction management/inspection services for the San Pablo Avenue Complete Streets Project.

BE IT FURTHER RESOLVED there are no additional fiscal impacts.
