RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A ONE-TIME SPONSORSHIP SUPPORT IN THE AMOUNT OF \$1,500 TO THE TARA HILLS RECREATION ASSOCIATION FOR THEIR 2018 BASEBALL SEASON

Fiscal Resiliency Policies: Spending Cap & Facility Use Policy for Maple Hall Waivers and Spending Cap & Special Event Sponsorship (Discretionary Spending) and Services for Families, Seniors & Youth, 4.11 Youth Program Services; Family Engagement; Collaborative Funding Partnerships are adopted policy items under the FY 2015-17 Council Priority Workplan, effective October 1, 2016;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, on September 28, 2017 the City Manager's Office received a request from Monique August, Sponsorship Chairperson for the Tara Hills Recreation Association Inc., requesting monetary support for their 2018 baseball season;

WHEREAS, in 1963, Tara Hills Recreation Association was established in the community with a mission to give local youth a safe environment to grow and thrive by learning basic value and the importance of sportsmanship; and

WHEREAS, Tara Hill Recreation Association is a non-profit organization with a respected history in the community and since inception, Tara Hills Recreation has impacted over 13,000 youth in the Bay Area through their Spring and Fall baseball leagues, instruction and tournament opportunities.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo authorizes the sponsorship in the amount of \$1,500 to help the Tara Hills Recreation Association continue to enrich the lives of the youth; and

BE IT FURTHER RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings; and

BE IT FURTHER RESOLVED A total of \$30,000 has been budgeted and earmarked for Event Annual Sponsorship for FY2017/18 under the Adopted FY 2018/21 Quadrennial Operating Budget – City Council Department (100-1110-44050). The authorized sponsorship in the amount of \$1,500 will be deducted from this expense balance and will exhaust the budgeted balance for the remainder of FY 2017/18 period for future sponsorships by the City Council.
