RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO AMEND AN EXISTING ENGINEERING DESIGN CONTRACT WITH BKF ENGINEERS TO ADD \$12,154, INCLUDING A 15% CONTINGENCY, FOR ADDITIONAL LIGHTING DESIGN SUPPORT FOR AN AMENDED TOTAL NOT TO EXCEED CONTRACT AUTHORIZATION OF \$683,260 FOR THE SAN PABLO AVENUE COMPLETE STREETS PROJECT (SPA-CST)

WHEREAS, City of San Pablo was awarded \$5,978,000 in One Bay Area Grant (OBAG) funds for the San Pablo Avenue Complete Streets Project while the design and environmental review and construction management/inspection are jointly funded by the City of San Pablo and the City of Richmond, each contributing \$615,000;

WHEREAS, the City of San Pablo filed a Notice of Exemption for the project with the Contra Costa County on October 24, 2016;

WHEREAS, pursuant to Resolution 2015-058, the City Council approved the grant matching funds in the amount of \$1,230,000 jointed funded by the City of San Pablo and the City of Richmond for the San Pablo Avenue Complete Streets Project;

WHEREAS, pursuant to Resolution 2015-105, the City Council authorized a design services agreement with BKF Engineers for Design and Environmental Review and approved the funding allocation of \$579,534;

WHEREAS, pursuant to Resolution 2017-161, the City Council authorized a construction management services agreement with Park Engineering, Inc. for construction management and inspection and approved the funding allocation of \$650,466;

WHEREAS, pursuant to Resolution 2018-019, the City Council awarded the construction contract to Ghilotti Bros., Inc. for a total authorization amount of \$5,812,093;

WHEREAS, pursuant to Resolution 2018-041, the City Council approved the acceptance and appropriation of additional OBAG funding of \$165,907 and authorized the contract amendment with BKF Engineers to add the construction support work bringing the total contract authorization to \$671,106;

WHEREAS, pursuant to Resolution 2018-050, the City Council approved an appropriation of \$150,000 toward the San Pablo Avenue Complete Streets Project for streetlight upgrade;

WHEREAS, staff is communicating with the funding agency regarding the proposed scope change and has obtained a cost proposal from BKF Engineers to perform the additional lighting design services and request approval for contract amendment in an amount of \$12,154 including a 15% contingency; and

WHEREAS, all work including the requested amendment is being funded within the approved and appropriated project budget of \$7,360,000.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of San Pablo hereby authorizes the City Manager to amend the engineering design contract with BKF Engineers to increase the contract authorization of \$671,106 by \$12,154, which includes a 15% contingency, for a total contract authorization not to exceed \$683,260; and.

BE IT FURTHER RESOLVED that upon closure of the San Pablo Avenue Complete Streets Project (SPA-CST) that any remaining funding will be reallocated to the San Pablo Avenue Decorative Street Light Beautification Project budget account (320-3200-43600-LGT-CIT).
