RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH CONSTRUCTION WEST SERVICES, INC. IN THE AMOUNT OF \$89,458 FOR THE CHURCH LANE SENIOR CENTER OPERABLE PARTITION PROJECT, WITH A 15% CONTINGENCY FOR A TOTAL AUTHORIZATION OF \$102,876 TO BE FUNDED BY BUDGET ADJUSTMENTS FROM BUILDING AND FLEET MAINTENANCE AND STREET LIGHTING AND LANDSCAPING IN THE CIP BUDGET

WHEREAS, the Community Services and Public Works Departments have identified a need to install a movable/retractable partition that spans approximately 40 feet across the existing Church Lane Senior Center Multi-Purpose room;

WHEREAS, the City of San Pablo requested informal bids for this project; the City received two bids, and Construction West Services, Inc. was the lowest responsive and responsible bidder; and

WHEREAS, funding to cover the \$102,876 cost of repair is available in the Fiscal Year 2017/18 City of San Pablo Operating Budget (100-3410-43600) in the amount of \$59,415, (237-3610-46100) in the amount of \$23,461; and (237-3610-46300) in the amount of \$20,000.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council of San Pablo authorizes the City Manager to execute an agreement in the amount of \$89,458 with Construction West Services, Inc., with an available contingency of 15% for a total cost of \$102,876 to construct the Senior Center Operable Partition Project.

BE IT FURTHER RESOLVED that the City Council of San Pablo authorizes the City Manager to execute budget transfers to fund the project as follows:
