RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE WAIVER OF FEES FOR USE OF RUMRILL SPORTS PARK PRACTICE FIELD AND A 2/3RD REDUCED FEE AT RUMRILL SPORTS PARK FOR FIELDS 1 AND 2 (TOTALING \$10,860) FOR THE SAN PABLO UNITED YOUTH SOCCER CLUB (SPUYSC) FOR THE 2018 SUMMER/FALL SEASON

WHEREAS, Healthy Eating Active Living Initiatives: Low Cost Recreation Youth Programs for Income Sensitive Residents AND Services for Families, Seniors & Youth: Operating Space for Non-Profit Organizations are adopted policy items under the FY 2018-21 City Council Priority Work plan, effective February 20, 2018;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, on November 30, 2017 Rafael Torres, President of San Pablo United Youth Soccer Club (SPUYSC), submitted a letter of request to the City Manager requesting the waiver of fees for Rumrill Sports Park (Fields 1, 2, & 3):

- Rumrill Sports Park from August 6, 2018 November 16, 2018
 - Monday Friday from 5:00 PM 8:00 PM
 - Saturday and Sunday from 8:00 AM 5:00 PM; and

WHEREAS, SPUYSC is a volunteer-run, non-profit organization dedicated to the youth and families in the City of San Pablo to provide the opportunity to play soccer to approximately 200 boys and girls ages 3 to 18 years;

WHEREAS, through the sport of soccer, the SPUYSC has been able to increase active healthy participation for participants in an outdoor environment. SPUYSC has also been able to promote sportsmanship, leadership and teambuilding skills;

WHEREAS, SPUYSC is attempting to reassure families that by being in partnership with the City of San Pablo that children will be protected regardless of their religion, race, gender, or immigration status and that no children are left behind due to socioeconomic disadvantages;

WHEREAS, it is requested that there will be a full fee waiver for use of the practice field at Rumrill Sports Park along with a 2/3rd fee waiver for Fields 1 and 2 at Rumrill Sports Park;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver;

WHEREAS, the fiscal impact for FY 2018/19 (2018 summer/fall season) will be subsidizing approximately \$10,860 in rental revenue for Rumrill Sports Park; and

WHEREAS, this item was taken before the Community Services Standing Committee (Morris/Calloway) on June 11, 2018 where they unanimously supported the recommendation to move forward to City Council to approve the fee waivers requested by San Pablo United Youth Soccer Club for the summer/fall season ending December 10, 2018.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of the City of San Pablo authorizes the City Manager to waive the field rental fees for the San Pablo United Youth Soccer Club for the use of the Rumrill Sports Park Practice Field and to waive 2/3rds of the fee for Rumrill Sports Park Fields 1 and 2 for a total of \$10,860 for the 2018 summer/fall season.
