RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING A FEE WAIVER IN THE AMOUNT OF \$6,960 FOR THE SAN PABLO COWBOYS YOUTH ASSOCIATION (SPCYA) USE OF DAVIS PARK SPORTS FIELDS AND CONCESSION STAND FOR THE 2018 SUMMER/FALL SEASON

WHEREAS, *Healthy Eating Active Living: Low Cost Recreation Youth Programs for Income Sensitive Families AND Services for Families, Seniors & Youth: Capacity Building & Operating Space for Non-Profit Organizations* are adopted policy items under the FY 2018-21 City Council Priority Work plan, effective November 1, 2017;

WHEREAS, on May 3, 2018 Andre Williams, President of SPCYA, submitted a letter to the City Staff requesting City Council waive fees for Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field) and the Davis Park Concession Stand on the following dates and times:

Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field)

- Davis Park Sport Fields (Youth Diamond/Sports Field and Mini Diamond/Sports Field)
 - July 23, 2018 - December 10, 2018 on Monday - Friday
 - 5:00 PM - 8:00 PM
- Davis Park Concession Stand
 - July 23, 2018 - December 10, 2018 on Monday - Friday
 - 5:00 PM - 8:00 PM

WHEREAS, San Pablo Cowboys Youth Association offers a diverse football program that provides approximately 200 San Pablo youth the ability to travel to numerous cities and compete against various football programs. Participants are rewarded for their accomplishments in athletics as well as scholastics to assure them that they are always winners just for taking the initiative to do their best;

WHEREAS, the fiscal impact for FY 2018/19 (2018 summer/fall season) will be subsidizing approximately \$6,960 in rental revenue for Davis Park Sport Fields and Concession Stand;

WHEREAS, the Application Fee and the Damage/Cleaning Deposit are not eligible for a fee waiver;

WHEREAS, this is not a project as defined by CEQA; and

WHEREAS, this item was taken before the Community Services Standing Committee on June 11, 2018 where they unanimously supported the recommendation to move forward to City Council to approve the fee waivers requested by San Pablo Cowboys Youth Association for the summer/fall season ending December 10, 2018.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED the City Council of San Pablo authorizes the City Manager to waive the field rental fees for the San Pablo Cowboys Youth Association for the use of the Davis Park Fields and Concession Stand for the 2018 summer/fall season as described above in the amount of approximately \$6,960.
