

RESOLUTION 2018-084

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO (1) DESIGNATING THE CITY MANAGER, ADMINISTRATIVE SERVICES DIRECTOR AND PUBLIC WORKS DIRECTOR AS THE CITY'S AUTHORIZED AGENTS FOR THE PURPOSES OF OBTAINING FINANCIAL ASSISTANCE FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND THE STATE OF CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES (CAL OES) FOR DISASTER AID; (2) APPROVING THE CORRESPONDING CAL OES FORM 130; AND (3) AUTHORIZING THE CITY MANAGER TO EXECUTE AND FILE THE CAL OES FORM 130 AND RELATED DOCUMENTATION

WHEREAS, in early 2017, severe winter storms caused widespread flooding, mudslides, erosion and damage to roads and other public infrastructure and facilities throughout California;

WHEREAS, to help communities recover from the storm damage, the California Governor issued emergency proclamations which the President approved and subsequently declared major disasters making federal disaster aid available to public agencies located in over 40 counties in the State of California, including Contra Costa County;

WHEREAS, San Pablo experienced significant damage to some infrastructure, and repairs are eligible for FEMA and Cal OES financial assistance; and

WHEREAS, in order for Cal OES to complete processing the City's Request for Public Assistance, the City Council must designate City agents responsible for providing required assurances and executing agreements with FEMA and Cal OES on behalf of the City and approve the corresponding Cal OES Form 130.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of San Pablo, that it hereby designates the City Manager, Administrative Services Director and Public Works Director as the City's authorized agents for the purposes of obtaining financial assistance from FEMA and Cal OES for disaster aid; approving Cal OES Form 130, attached to the Resolution as Exhibit A; and authorizing the City Manager to file the Cal OES Form 130 and related documentation with Cal OES.

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon passage and adoption.
