RESOLUTION 2018-102

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO, CONTRA COSTA COUNTY, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENTS WITHIN SAN PABLO STREET LIGHTING AND LANDSCAPE ASSESSMENT DISTRICT NO. 1982-1 FOR FISCAL YEAR 2018/19; (2) DIRECTING CITY CLERK TO FILE THE DIAGRAM AND ASSESSMENTS WITH THE COUNTY AUDITOR NO LATER THAN AUGUST 10, 2018; AND (3) LEVYING SAID ASSESSMENTS

WHEREAS, in August, 1982, the City Council of the City of San Pablo ordered the formation of and levied the first assessment within San Pablo Street Lighting and Landscape District No. 1982-1;

WHEREAS, Assessment District No. 1982-1 received approval from approximately two thirds of the voters voting in the General Election held on November 5, 1996, and is exempt from the procedures and approval process set forth in Section 4 of Article XIII D of the California Constitution;

WHEREAS, Resolution 2018-031, directed the Assessment District Engineer to prepare and file a report for the levy of annual assessments within San Pablo Street Lighting and Landscape Assessment District No. 1982-1 for fiscal year 2018/19, was adopted March 5, 2018;

WHEREAS, the Assessment District Engineer did file a report with the City Clerk and the assessments are not proposed to increase from fiscal year 2017/18 assessments;

WHEREAS, on June 18, 2018, the City Council adopted Resolution 2018-081, which preliminarily approved the Engineer's Report; declared the City's intention to levy and collect assessments for fiscal year 2018/19; set a date for a Public Hearing; and directed the City Clerk to publish a notice of said Public Hearing pursuant to Streets and Highways Code Section 22626(a) and Government Code Section 6061, which notice has been published;

WHEREAS, on July 2, 2018, the City Council held a Public Hearing on the levy of proposed assessment for San Pablo Street Lighting and Landscape Assessment District No. 1982-1 for Fiscal Year 2018/19, afforded all interested persons the opportunity to hear and be heard, and considered all oral statements and written communications made or filed by interested parties.

NOW THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to hereby confirm the diagram and assessment as set forth within the amended Engineer's Report; and

BE IT FURTHER RESOLVED that this Resolution shall constitute the levy of an assessment for Fiscal Year 2018/19 within San Pablo Street Lighting and Landscape Assessment District No. 1982-1, as referred to in the Engineer's Report; and

BE IT FURTHER RESOLVED that this Council directs the City Clerk to file immediately the diagram and assessment, or a certified copy of it, with the County Auditor.
