

## **RESOLUTION 2018-098**

### **RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN PABLO AUTHORIZING THE SAN PABLO POLICE DEPARTMENT TO ACCEPT \$612,056 IN GRANT FUNDING FROM THE CALIFORNIA DEPARTMENT OF JUSTICE TO PARTICIPATE IN THE TOBACCO LAW ENFORCEMENT GRANT PROGRAM AND APPROPRIATE FUNDING IN THE SAME AMOUNT TO THE POLICE DEPARTMENT BUDGET TO DEVELOP AN EFFECTIVE, COMPREHENSIVE AND STRATEGIC APPROACH TO COMBAT ILLEGAL TOBACCO USE AMONG MINORS**

WHEREAS, Budget Spending Control is an adopted policy item under the FY 2018-21 Council Priority Work Plan, effective November 1, 2017. In addition, Reducing Promotion of Unhealthy Tobacco Products to Youth, Community Outreach, and Priority Oriented Policing Program are adopted policy items under Public Safety in the Work Plan;

WHEREAS, the Priority Oriented Policing (POP) Unit is tasked with working with local businesses, schools, and community members to address priority issues which impact our community. These issues include addressing state and local laws of licensed tobacco establishments within San Pablo;

WHEREAS, this is not a project as defined by CEQA;

WHEREAS, the City of San Pablo has more than 60 tobacco outlets within 2.6 square miles. The large majority of licensees surround our community schools, parks, and community centers;

WHEREAS, the San Pablo Police Department was selected by the California Department of Justice (DOJ) and funding is available to participate in the "Tobacco Law Enforcement Grant Program";

WHEREAS, the City of San Pablo supports the grant goals and wishes to participate in the "Tobacco Law Enforcement Grant Program";

WHEREAS, the Police Department requests approval to accept funding to participate in the "Tobacco Law Enforcement Grant Program" and for the purchase of related equipment, training, the salary of staff to conduct community outreach, education, training, and specific enforcement operations. Additionally, the POP Unit will conduct inspections and provide training to local business owners on relevant issues, laws, and responsibilities of licensed tobacco establishments. The grant period is from July 1, 2018 through June 30, 2020; and

WHEREAS, the total amount of requested DOJ funding is \$612,056.

NOW, THEREFORE, BE IT RESOLVED that the foregoing recitations are true and correct, and are included herein by reference as findings.

BE IT FURTHER RESOLVED that the City Council authorizes the San Pablo Police Department to accept the \$612,056 in grant award for the California DOJ Tobacco Law Enforcement Grant Program and appropriate funding in the same amount to the Police Department per the following table to achieve the goals of the grant.
